__Payment Option 1: To secure my child’s enrollment in camp, I will pay the non-refundable \$75 registration fee and my \$250 nonrefundable deposit (\$325 total) upon registration and I will make equal 3 payments April 1, 2023 / May 1, 2023 / June 1, 2023, for the balance. __Payment Option 2: I am paying in full at time of registration for camp 2023 and including my security fees and registration fee of \$75. I will receive a 5% discount on tuition only, not before/after care, registration fees or security fees (Discount valid until April 30, 2023). After May 1st payment in full is due to register for camp.

- ____ 2. I understand that the withdrawal policy states that I must give written notification of withdrawal at least 15 days prior to the first day of camp. There are no refunds after May 15, 2023.
- ____ 3. In the event of an emergency, if I am unable to be contacted, I hereby grant permission to Temple Torat Emet to authorize any emergency action necessary to ensure the safety of my child.
- ____ 4. Participation in any Wiston Family Torah Tot activities and use of any recreation facilities involves a risk of accidental injury despite all safety precautions. Wiston Family Torah Tots Camp 2023 Closure Policy

This policy addresses the financial implications If our Torah Tots camp program will need to close due to advisement from the state of Florida.

It is our every intention to begin camp and run as per our camp calendar. The sole impediment will be if/when Florida's Health Department and/or Medical Experts that have been retained, determine it unsafe to do so.

Such stoppages could vary from very temporary, to a longer duration of time. In consideration of these various possibilities, we have determined the following:

- Any camp/class closure of 10 (consecutive) days or less, will not affect tuition fees. There will be no reduction/refund of tuition.
- If a camp/class closure extends beyond 10 camp days up till 20 camp days, the camp will offer a reimbursement of tuition fees, based on a daily rate for the time closed.
- If the closure extends beyond 20 days, parents will be released of camp fee financial obligations to Wiston Family Torah Tots, and you will receive a refund for the remaining days based on the method of payment within 45 days.

We sincerely hope that you can find comfort in knowing that Wiston Family Torah Tots ECLC 2023 camp program is committed to providing the safest, healthiest environment for your children.
