- _____ 3. In the event of an emergency, if I am unable to be contacted, I hereby grant permission to Temple Torat Emet to authorize any emergency action necessary to ensure the safety of my child.
- _____ 4. Participation in any Wiston Family Torah Tot activities and use of any recreation facilities involves a risk of accidental injury despite all safety precautions. Wiston Family Torah Tots Camp 2026 Closure Policy

This policy addresses the financial implications If our Torah Tots camp program will need to close due to advisement from the state of Florida.

It is our every intention to begin camp and run as per our camp calendar. The sole impediment will be if/when Florida's Health Department and/or Medical Experts that have been retained, determine it unsafe to do so.

Such stoppages could vary from very temporary, to a longer duration of time. In consideration of these various possibilities, we have determined the following:

- Any camp/class closure of 10 (consecutive) days or less, will not affect tuition fees. There will be no reduction/refund of tuition.
- If a camp/class closure extends beyond 10 camp days up until 20 camp days, the camp will offer a reimbursement of tuition fees, based on a daily rate for the time closed.
- If the closure extends beyond 20 days, parents will be released of camp fee financial obligations to Wiston Family Torah Tots, and you will receive a refund for the remaining days based on the method of payment within 45 days.
